All Boat Stands must have **3 SIDED PROP SHIELDS MADE OF SOLID MATERIAL & IMMOVEABLE WHEN ENGINE IS STARTED** if centerline of driveshaft is more than 12 inches above ground. **This rule applies in hot pits & work areas!** • **NAMBA # MUST BE ON BOATS & back of your shirts.** Engines may NOT be run in the hot pits while a heat is in progress • Gas racers must provide fire extinguishers Transmitters must be narrow banded & have your name and frequency flag on them. • 95 db rule enforced. All engines must have a chambered muffling device or water injection. • These & all other NAMBA & District 1 rules will be enforced. It is your & your pitperson's responsibility to be familiar with them.

### **DIRECTIONS TO SAFFIN POND**

Take Route 80 West (if coming from N.Y.) or Route 80 East (if coming from Penna.). Get off at Route 15 North To Sparta. Continue on Route 15 North approximately 5 miles to Weldon Road Exit. Bear Right onto Weldon Road approximately 3 miles until you come to a sign which says "Saffin State Park" Proceed past sign, around a curve until you come to Saffin State Park Parking Lot on your right. When entering the parking lot proceed to the right to a gate across a road. Proceed down this road to the race sight. **DRIVE SLOW! PEOPLE MIGHT BE WALKING AT SIDE OF ROAD.**

***THIS IS A COUNTY PARK. PETS MUST BE KEPT ON LEASH AT ALL TIMES. TOILET & PICNIC FACILITIES AVAILABLE AT RACE SITE.***

***DUE TO COUNTY PARK COMMISSION RULES YOU MAY DRIVE TO THE LAKESITE TO UNLOAD & LOAD BUT YOU THEN MUST PARK IN THE DESIGNATED PARKING LOT.***
